I will work collaboratively with CVWD and CVMVCD to execute a Mosquito Reduction Best Management Plan Agreement; meter all groundwater wells used for groundwater production including artesian flows; execute a Water Production Metering Agreement; and provide documentation of work completed to properly cap, seal, modify, repair, or destroy the artesian well(s) on my properties. I understand satisfying these requirements are a prerequisite for consideration for this rebate.</p>	
<p>3. I understand all rebates (i.e. awards) over \$600.00 require the completion and submittal of a W-9 Request for Taxpayer Identification Number and Certification form. CVWD will use the applicant's W-9 information to issue a 1099-MISC Miscellaneous Income form to the Internal Revenue Service (IRS) and award recipient on or before January 31st of each year. All individuals or entities are obligated to report awards to the IRS which may have tax implications.</p>
