

Weather-based irrigation clock program

TERMS AND CONDITIONS

ELIGIBILITY:

1. All participants must be a Coachella Valley Water District customer and the property owner of the installation site. The installation site must be located within one of the participating cities.
2. The applicant must have an account in good standing with the District and the site must have a minimum of one year of water consumption history so that a pre- and post-water consumption comparison can be conducted.
3. The participant must have a fully functioning irrigation control system.

CONDITIONS:

1. The participant must be present for the pre-inspection and installation site visits.
2. The participant agrees to leave the "Weather-Based" irrigation controller in place for a minimum of one year provided that ownership of the property does not change.
3. The water district and participating cities have purchased a limited number of clocks per city for the program. Controllers will be distributed on a first-come, first-served basis within each city until supplies are exhausted. Only one controller will be allowed per water district customer.
4. The participant agrees to allow the Coachella Valley Water District to inspect the property at any time within the first year.
5. The district will install and initially program the controller, and provide up to one follow-up visit, if needed. Any further follow-up visits will be charged \$75.00 per visit. Regular maintenance and continued programming of the controller is the responsibility of the participant. Customer initial_____
6. The participant agrees to allow the District to contact him or her for the purpose of conducting program research and agrees to participate in the customer satisfaction poll at the conclusion of the program.
7. The participant has read and agrees to the conditions set forth in the following disclaimer:

Neither the Coachella Valley Water District nor the participating cities, nor their contractors or agents, makes any representation or warranty regarding the irrigation controller utilized in this Weather Based Irrigation Controller Program. By participating in the program, you waive and release the Coachella Valley Water District, The participating cities and their contractors and agents, from any and all claims and causes of action arising out of the purchase, installation or use of the irrigation controller purchased in connection with the Weather Based Irrigation Controller Program. Any claim you may have based upon any defect or failure of the performance of the irrigation controller purchased by you in conjunction with this rebate program should be pursued with the manufacturer.

ABOUT THE PROGRAM:

The Coachella Valley Water District is purchasing, installing and programing weather-based irrigation controllers at a significantly reduced rate in conjunction with some Coachella Valley cities. Only water district customers living in the participating cities are eligible to participate in the program. Supplies are limited.

Weather-based irrigation clocks automatically adjust your irrigation system's run time based on historic weather data, reducing the amount of water in the cooler months and increasing the amount in the summer. Coachella Valley homeowners who currently don't manually adjust their irrigation controllers and switch to a self-adjusting system have cut their water usage by an average of 26 percent. That also means a lower monthly water bill.

HOW TO APPLY:

1. Read the Terms and Conditions on the reverse side. You must meet the eligibility requirements to participate.
2. Complete the application here and submit it to the water district. You may submit the application in person at either the water district's Coachella or Palm Desert offices or via mail. Applications will be processed in the order received. Cost of the program is **\$50** for an indoor Aqua Conserve, six-station system or **\$100** for an outdoor Aqua Conserve, eight-station system. For systems requiring more than eight-stations a RainBird ESP-SMT, seven-station system is **\$100**, a ten-station system is **\$125** and a thirteen-station system is **\$150**.
3. If you qualify, a water district employee will contact you to schedule an appointment for a pre-installation visit and evaluation of your current system. Applicant must be present for the visit.
4. If it's verified that you have a working system, a water district employee will order and schedule an appointment to install and program your new irrigation controller. Applicant must be present for the installation.
