Residential Hot Water Recirculating Pump Rebate Program

ABOUT THE PROGRAM

Coachella Valley Water District (CVWD) is offering a rebate program for installing a new Hot Water Recirculating Pump for residential customers living within CVWD's service area. CVWD will offer a maximum of \$125 rebate, or the cost of the recirculating pump, whichever is less. Customers will be responsible for providing a completed application, color photo of the installed recirculating pump, and sales receipt. CVWD will reimburse the customer after all program conditions have been met.

TERMS AND CONDITIONS

ELIGIBILITY

1. All applicants must be a CVWD customer and property owner of the residence. The residence must be located within CVWD's service area.
2. The customer must have an account in good standing with CVWD.

CONDITIONS

1. Customer must complete and sign a program application.
2. The rebate is limited to one (1) per household for a single-family dwelling; or one (1) rebate application per unit for a multi-family dwelling duplex, triplex or four-plex.
3. Customer agrees to purchase and install a hot water recirculating pump at customer's expense.
4. Customer must submit 1) application, 2) receipt(s), and 3) color photos of installed pump system within 60 days of purchase. The program is not for new construction and is not retroactive to hot water recirculating pumps purchased more than 60 days before the application is received. CVWD will not reimburse for the cost of installation.
5. Customer must provide a cash register receipt along with the sales invoice, if one is issued, indicating the make and model purchased from a home improvement store, or other retail outlet that sells new hot water recirculating pumps. For hot water recirculating pumps purchased through a plumber or contractor, the invoice from the contractor with the make, model, and cost of the pump stamped "Paid in Full" will be acceptable as proof of payment. Installations may be subject to site visit inspection.
6. Customer agrees that when all program conditions are met, CVWD shall reimburse an amount up to One Hundred and Twenty-Five Dollars (\$125) per hot water recirculating pump. A rebate check will be mailed to the applicant within 60 days.
7. Customer has read and agrees to the program conditions and the following disclaimer:

Coachella Valley Water District reserves the right to offer this program. By applying for or participating in any component of CVWD's programs, personal information listed on your application may be subject to disclosure to any member of the public who requests it pursuant to the California Public Records Act.

Coachella Valley Water District administers the Hot Water Recirculating Pump Rebate Program on a first-come, first-served basis, subject to availability of funds and all other applicable program conditions. This program may be discontinued or modified at any time. By participating in the program, you waive and release Coachella Valley Water District from any and all claims and causes of action arising out of the purchase, installation, or use of the Hot Water Recirculating Pump. Any claim you may have based upon any defect or failure of the performance of the Hot Water Recirculating Pump purchased by you in conjunction with this program shall be pursued with the retail outlet and the manufacturer or installation contractor.
